Dear Parents,

At Groves, we have an open campus lunch policy for 11<sup>th</sup> and 12<sup>th</sup> grade students. This allows students to leave the Groves campus during their lunch period. Please speak with your child about these important parameters:

1. Junior and Senior grade level students must have parent/guardian permission to participate in open lunch.\* Once permission is granted, students will be issued the designated lunch pass. Freshman and Sophomore students are not permitted to leave campus during lunch time.
2. Students must show their student ID card as they leave the building.
3. Students may be asked to turn in their lunch pass for the following reasons:
  - Arriving to class late
  - Taking underclassmen off campus for lunch
  - Violating the code of conduct
  - Reckless driving during school hours and/or while driving to or from a school sponsored event.

Our Open Lunch policy is a privilege for students. Prior to giving parental permission, it would be quite appropriate for parents to take into consideration such factors as:

- a child's driving record
- the quality of the student's decision making
- the degree to which the student regularly demonstrates responsible behavior within the family, school, and the greater community.

Being respectful and responsible to yourself and others is part of the GROVES Way. We look forward to supporting our students in demonstrating these tenets during lunchtime.
